



## CONTRACT FOR STORAGE OF GOODS

This contract for the Storage of Goods is made effective upon collection of goods to be stored by client.

In consideration of mutual covenants contained in this agreement, the parties agree as follows:

### 1. RATES FOR STORAGE, HANDLING AND TRANSPORT

Acts Cont agrees to perform storage, handling and transport of the following merchandise, referred in this agreement as 'Goods', at the following rates, as required by Acts Cont in the course of its business during the term of this agreement:

**2. TERM OF AGREEMENT**

d. Storage charges become applicable the day following pick of goods . Half of the total amount for storage charges are to be paid by depositor before or on the pick-up date of goods and the other half before collection thereof. Goods will be charged from the day after goods have been stored.

e. If payment is not made in terms of clause 3c before the pick-date of goods, then the agreement is terminated. If payment is not made in terms of clause 3c before the collection date, **interest of 50% of outstanding amount will be charged per week**. Upon goods not having been collected 2months after collection date, without notification upon a later reasonable collection date, Acts Cont reserves the right to obtain a court order to sell the Goods to obtain payment.

## **6. DELIVERY OF GOODS**

a. Depositor will notify Acts Cont of the address where Goods are to be delivered to, within 2 weeks of delivery date.

If depositor notifies Acts Cont of him not being within Johannesburg upon delivery date, a later delivery date will be established upon agreement between Acts cont and the depositor and charges will be allocated according to the weekly charge; therefore if depositor's new delivery date is on a Monday, he will pay for that entire week.

d. If depositor asks for delivery to a place outside of Johannesburg, an additional fee for petrol costs will be charged pending upon where goods are to be delivered to.

## **7. LIABILITY OF Acts Cont**

Acts Cont accepts full liability for all Goods and any damage thereof. Repairs on damage goods will be made or replacement thereof, upon discretion of Acts Cont.

## **9. CANCELLATION OF AGREEMENT**

This agreement may be cancelled by either Acts Cont or depositor within 15 days upon Goods already having been stored, where in a charge of **R20** per day of storage will become payable by the depositor together with a cancellation fee of **R100**. Cancellation is to be written and submitted to the other party to the agreement within the period of 15 days.

## **10. NON-VARIATION OF AGREEMENT**

No variations will be made to this agreement. If depositor wishes to store more goods, a new agreement will be drawn up and signed.

## **11. EFFECT OF AGREEMENT**

The rights and liabilities set forth in this agreement shall inure to be benefit of and be binding on, Acts Cont and the depositor and their respective heirs, executors, administrators, successors, and assigns.
